## I understand and agree to the following terms and conditions of the loan with Dolen Teifi:

Where appropriate, I will ensure that my child or member of my organisation using the bike understands our agreement and they will carry out the following with me or for my organisation.

1. I am responsible for the security of any Dolen Teifi bicycle loaned to me. I will take care of the bicycle that I am provided with, securing it to something immovable whenever it is left unattended, with the lock provided/bought. Overnight, electric bikes and cargo bikes will be locked inside a secure building with no public access (e.g. my house).
2. I will not abuse any Dolen Teifi bicycle loaned to me; in particular, I will not use a Dolen Teifi bicycle for racing, mountain bike riding, stunt or trick riding or for any purpose other than cycling to and from a destination. On electric bikes, I will not adjust or tamper with any setting or cabling other than those explicitly explained to me by Dolen Teifi.
3. I am responsible for the maintenance of any Dolen Teifi bicycle loaned to me. I will maintain the bicycle that I am provided with in a safe and roadworthy condition for the period of the loan. I will refer to and abide by the Dolen Teifi electric bike user instructions at all times. If a fault develops and I am unable to keep the bike in a safe and roadworthy condition, I will return the bicycle to Dolen Teifi.
4. I will let Dolen Teifi know if for any reason the bicycle is not being used. If the bicycle is lost or stolen I will report this to the police and to Dolen Teifi as soon as possible.
5. I will return the bike and equipment in a clean condition and at the appointed time and understand that Dolen Teifi reserves the right to charge me for loss or exceptional damage to the bike.
6. Dolen Teifi does not insure the user of any loan bicycle provided. Dolen Teifi does not seek to exclude or limit its liability for any death or personal injury directly resulting from its own negligence. Dolen Teifi is not responsible for any injury or any loss or damage to any property or to any person or consequential losses resulting from my use of a Dolen Teifi loan bicycle. I take full responsibility for any such injury, loss or damage to any property or to any person or any consequential losses arising howsoever caused.
